

Information Notice for Personal data processing referred to Art.13-14 EU Regulation N.2016/679 ('GDPR')

Geo.coil s.r.l. headquarters in via Buja, 6 in Artegna (UD) Italy VAT id. No. IT 02098420306 (hereafter referred to as the 'Data Controller' or 'Geo.coil') pursuant to and for the purposes of Art.13 n.196 (as 'Privacy Code') and Art. 13 UE Regulation N. 2016/976 (as 'GDPR') informs you about the processing of your personal data as follows:

1. Data subject

Your personal data, as name, surname, address, phone no., e-mail address, bank details for payments and so on, you supplied are used for the execution of the obligations and contracts.

2. Purposes

Your personal data are processed:

- A) Without your authorisation:
 - -to perform contracts
 - -to carry-out pre-contractual obligations, obligations and fiscal obligations
 - -to fulfil obligations provided by law, regulations, UE legislation or on order of the Public Authorities (for istance 'anti-money laundering')
 - -to practice the right of defence by the Data Controller in judgment.
- B) With your specific authorisation for marketing purposes:
 - -to send per e-mail, mail and/or phone-calls commercial communications and/or advertising material about products and services offered by the Data Controller.

3. Methods of processing

The processing of personal data are based on principles of correctness, legitimacy, transparency and can be effected also through electronic tools memorising, managing and transmitting with procedures strictly related to the purposes and in any case in such a way as to guarantee the confidentiality and security of personal data. Your data is processed as paper and/or digital format.

The Data Controller uses your data for the purposes only and no more than 10 years after the cessation of the relationship.

4.Data Access

Your data can be accessible

- -to the personnel and collaborators as entrusted and/or internally responsible, and/or system administrators
- -to external structures and/or companies that Geo.coil relies on.

5. Communication

Without express consent the Data Controller can communicate your personal data to the Public Authorities as requested by law. The latter can process your data independently. Data is not shared in any other way.

6. Transfer data

The treatment and retention of data takes place within EU.

7. Rights of the Data Subject

As Data Subject you have the following rights (as per art. 15):

- -to access to your data processed
- -to make correction of your data
- -to cancel or delete your data or part thereof
- -to block your data or part thereof
- -to transform your data into anonymous form
- -to object in whole or in part the processing of your personal data
- -to submit a complaint to the data Protection Authority in Italy (art.16-21).
